Notes to Financial Statements June 2019

Balance sheet Operating Cash on hand is \$39,890 Reserve CD funds are \$178,087 The Money Market reserve is \$73,364 that is a total of \$251,452 for the reserve. CD income for May was \$340.16. The money market reserve receives \$1,000 each month from the operating account in addition to the interest that is earned.

Accounts Receivable is \$940. This represents 1 home owner that has not paid the dues through June. That homeowner is now Paid up including the 3rd quarter.

Lawn maintenance is expected to exceed our annual budget and has spent 51.8% of the annual budgets. This is the 2018 Budget that we currently are using.

Roofing has spent 92.5 of the annual budgets but patio roofs have spent only 13% of the annual budget. There is no change from May as no additional work was completed for either repair or Patio roofs

With the new water monitoring system, I am reporting the 2018 expenditures versus the 2019 expenditure.

June is the 2nd month of significant water saving. It appears the watering program that Tenant has installed with our lease payments is working. January the program was not installed and the amount of \$1,124 was significantly greater that 2018. The other months from February thru June we have had savings totaling \$2,235. The lease payments thru June have been \$2,340. I believe the future months will keep reflecting the water management and will have significant savings the last six months greater than the lease payments.

Automatic withdrawals from the checking account include \$1,422 Waste disposal, \$1,422 for Water and \$1,000 for the Monthly reserve. This was completed with journal entry 536
