Balance sheet Operating Cash on hand is \$62,937. Reserve CD funds are \$139,096 The Money Market reserve is \$19,653, and CD's are \$119,443. CD income for June was \$233.00. The money market reserve receives \$1,590 each month from the operating account in addition to the interest that is earned. Cd income was estimated as I was unable to get in the bank at the time, I was preparing the statements.

Accounts Receivable is \$0 We do have one homeowner with a credit for the 4<sup>th</sup> quarter

Cutting & Trimming is on budget for the year, but most of the other line items are under budget including the water usage.

Payments were made on August 21 for Cincinnati Insurance co for \$1,353 and Auto Owners for \$16,319.56 For Villas exterior property insurance.

Automatic withdrawals from the checking account include waste disposal, \$1,371 for Water \$2,624 and \$1,590 plus \$233 interest for the Monthly reserve. This was completed with journal entry 601
