**GUEST SPEAKER:** Mr. von Barandy was the guest speaker and he began with an amusing story. He outlined the Association's accomplishments during 2018 and thanked the Board members for making 2018 a successful year. He also thanked the staff members for their outstanding work.

A homeowner said he noticed the new smaller trash cans are overloaded and asked if homeowners could go back to the larger cans. Mr. Meyer said to contact Republic, the trash provider. Their information is on the HOA website.
